TERMS AND CONDITIONS – SCHOOL FEES

I/We understand and accept

1. That I/we am/are jointly and severally liable for the payment of the full amount of fees and disbursements to be charged by St Francis College in respect of the whole period during which my son/daughter/ward is registered as a scholar at St Francis College, which amount includes but is not limited to, any other fees and/or disbursements charged by St Francis College from time to time. I/We declare that I/we am/are in a financial position to pay the school as adopted.
2. That payment is to be effected by one of the methods stipulated by the Trust.
3. That I/we shall be liable to pay interest on any school fees not paid on the due date.
4. That the deposit of R750 paid by me in regard to my son/daughter/ward is non-refundable and will be forfeited in the event of my cancelling the registration of my son/daughter/ward (New applicants only).
5. That any indulgence or extension granted by St Francis College with regard to payment of school fees will not be regarded as a waiver of any of the rights of St Francis College.
6. That in the event of school fees not being paid by the due date, whether by way of a term's advance payment or monthly debit order or payment, such failure on my/our part will cause the whole outstanding balance of the school fees then due to St Francis College at that time to become immediately due and payable.
7. That without limiting or detracting from the rights of St Francis College to enforce payment of any and all monies due to the school by applicant, St Francis College may in its sole discretion:
 - 7.1 withhold the pupil's school report if the fees for any given term are not paid by the end of that term;
 - 7.2 refuse the return of the pupil to St Francis College until the school fees are paid up to date
8. In the event of St Francis College being obliged to hand over any outstanding school fees for collection through its attorneys, I/we shall be liable for the legal costs incurred by the school for the collection of such outstanding fees on a scale as between attorney and client, including such collection commission which the school may be obliged to pay to its attorneys.
